City of Whitehouse Reallocation of Sales Tax Proposition – Reduction in rate of sales & use tax collected by the City of Whitehouse **for offsetting property taxes** and the transfer of that rate to a new sales & use tax for economic development. (tax swap)

Lindale ISD Bond Election – Issuance of \$32,410,000 of bonds by the Lindale Independent School District for School Facilities & the levying of a tax in payment thereof. [Note: the amount on the ballot is principal only & does not include the debt's interest.]
