


**Briefs are Filed With the Texas Supreme Court

Texas Attorney General's Office Submits Brief Requests Court to Address Constitutional Issues

Texas Attorney General, Ken Paxton, is Texas' top lawyer and is [charged](#) by the Texas Constitution to defend the laws and the Constitution of the State of Texas.



The AG's office submitted a [brief supporting](#) Pressley's appeal, "The question of whether unnumbered ballots cast using a DRE machine may lawfully be considered in a manual recount impacts what voting machines may be approved in Texas and is worthy of the Court's review." ([p.5](#)).

Because the Office of the Attorney General appoints members to the state committee that certifies voting systems, their office is interested in whether voting systems must number electronic ballots (in addition to paper ballots) under the [Texas Constitution](#).

Dr. Laura Pressley states, "We are very pleased with the balanced and detailed brief the Attorney General's office submitted to the Texas Supreme Court. It lays out the issues very concisely."

Pressley further adds, "Texans owe General Paxton and his office a huge debt of gratitude for addressing these constitutional voting issues. We look forward to the Court's consideration of the evidence presented."

Libertarian Party of Texas Files Brief Requests Court Address Constitutional Provisions, Election Laws and Sanctions

The Texas Libertarian Party bases its philosophy on [three core principles](#), constitutional rights, personal responsibility, and limited government. Attorney, Tom Glass, Chair of the Election Integrity Committee of the Libertarian Party of Texas, authored a powerful [Amicus Curiae Brief](#) that urges the Texas Supreme Court to grant Pressley's Petition and uphold the rule of law for Texas elections.

The brief respectfully requests that the Court provide guidance to counties and the Secretary of State regarding constitutional and statutory mandates for numbering electronic ballots used for manual recounts in Texas:



"Knowledge that rule of law prevails in Texas and that our Texas Constitution's provisions enacted to insure election integrity are followed is essential to stopping the erosion of confidence in our government by the general public."

"The issues in this case are not just for one election in the past. LPTexas and its nominees - indeed all parties' nominees for years to come -- will be affected by the Court's decision."

The Libertarian Party's brief further requests that the sanctions levied against Pressley be overturned. They cite the dangers these sanctions pose for future plaintiffs wanting to question how Texas elections are administered.

Pressley states, "We are grateful for the support of the Libertarian Party of Texas. It is very simple - Libertarians, Republicans, Democrats and independents all desire elections be administered according to the rule of law."
