We are constantly told that people illegally entering the US are only undocumented non-citizens migrating here and that only the federal government has jurisdiction over all immigration matters.

The political Left is in an information warfare (IO) campaign and is pushing propaganda in order to form our perceptions and beliefs that the border is simply a humanitarian issue, "only" about the poor and oppressed "trying to find work" and security and that Migration is a "human right." This ignores a fundamental issue – national sovereignty.

In the novel 1984, George Orwell came up with "newspeak." Words were REDEFINED by the Party, to advance its ideology. The principle was that if something can't be said, it can't be thought.

Languages of countries under dictatorships, such as the Soviet Union or Germany, deteriorated under their respective regimes. 2. Now that the security of the environment has been framed and measured as only an immigration situation, the Feds then declared that they have primacy over all immigration matters ("Border Security"); therefore, States have no "authority" over "securing" their border.

3. Now that the Feds have framed the environment as immigration and declared that States have no AUTHORITY over Border Security (IMMIGRATION), they then change the definition of immigration and citizenship.

The Left has blurred the lines between illegal and legal immigration and citizen and non-citizen to include changing the name of those who come to the U.S. illegally.

Immigration laws are not necessarily binding anymore. Biden has willfully rendered federal immigration laws null and void. Ideology governs when a law is still considered a law.

As a result, those who have violated federal law and resided without legal sanction, who are then arrested and charged with crimes, are protected from federal immigration enforcement and are not subject to deportation. This is happening on the border and in the interior of the U.S.

Legal citizenship is no longer necessary to live indefinitely inside the United States, to obtain legal identification, to qualify for state and federal social services, or to cross at will – at any time or place along our borders – without legal permission.

In other words, we are returning to 19th Century practices, when the westward expansion of the United States, coupled with commensurately small state populations, often meant that there were no enforceable borders. On the relatively empty frontiers, few cared to ascertain the legal status of residents. But whereas in the distant past demography explained legal laxity, today the explanation is politics—or, rather, the doctrine of radical equality of result that seeks to erode any discriminating criteria concerning those residing in the United States." - VDH

If the foundations to include definitions and enforcement of citizenship and immigration are being undermined, so too are its superstructures.

Our elites envision themselves as "citizens of the world" and, consequently, see their Americanism as passé. They prefer to respect the authority and reputation of transnational organizations rather than American legislative bodies and jurisprudence. *They declare migration is a human right!*

When you frame the border as only an immigration issue (crisis) and the only metrics used to determine the "security" of the environment are the number of apprehensions, turn backs & "gotaways" (humans and drugs), the Political left will be "justified" in stating that the border is simply a humanitarian issue, "only" about the poor and oppressed "trying to find work" and security because migration is a "human right."

Since our definition of a "secure" border is defined by a decrease in our border (immigration) metric number, the Left's propaganda infers that "securing" our border is separating families; denying global victims' God-given entitlements and rights; that it's a war on culture; it's racially dividing the nation; it's destroying global trade.

Once this is accomplished, maybe our officials and officers can start working together (instead of against each other in the media spotlight) to acknowledge that the truth about the border lies somewhere in the middle of "it's a war zone" and "to my knowledge, it's not happening."

Einstein reminds us that a problem must be well understood before it can be solved. Following that line of thinking, the Army Design Methodology (ADM) advocates framing the problem and the

operational environment before framing the solution.

My broad policy suggestion starts at the very beginning with a change in their definition of "invasion" and who is invading.

- b. Asymmetric Warfare Group w/ Johns Hopkins University also conducted a war-gaming conference in 2011 in an attempt to defeat the two largest cartels at that time (Zetas and Sinaloa) and secure the border.
- c. The 82nd Texas Legislature recognized this critical issue and the numerous accounts of cross-border violence and tasked the Texas Department of Agriculture via House Bill 4, to conduct: "an assessment of the impact of illegal activity along the Texas-Mexico border on rural landowners and the agriculture industry and working in conjunction with other appropriate entities to develop recommendations to enhance border security. **Sources:**

- d. We need another bill that includes a way to help pay for and organize an assessment. Results of that assessment should include:
- 1. Texas defines what a secure and stable border is.
- 2. Texas establishes the proper framework to assess the border's operational environment.
- 3. Texas establishes the metrics used to determine the security and stability of the environment.
- 4. Texas coordinates with other states like Ohio and creates an Interstate Uniformed Crime Report that will allow us to link ALL cartel-related activity throughout the U.S.

- 5. With the assessment, the State of Texas can justify and legally DECLARE the Cartels as terrorist organizations. Just such a bill was recently tried by State Representatives Bryan Slaton and Kyle Biederman and denied by the TXLEGE!!
- 6. The assessment would show that Terrorist Organizations (Mexican Cartels) <u>own and operationally</u> control both sides of the border.

- a. That assessment will also show that each person illegally entering (between or even at the Ports of Entry) paid to be smuggled and/or trafficked across; therefore, becoming a Cartel commodity.
- b. Illegal immigration will then be defined as a cartel operation and then it would be dealt with as such ENDING MASS MIGRATION.
- 7. Conduct a 3-day CCE, where those Subject Matter Experts who conducted the military assessment will host the event or summit, establish a shared understanding of the OE and then war game "Hackathon Style" to find solutions.

- a. Coordinate with Dan and Margaret Byfield behind the Border 391 Commission in order to FORCE Abbott to ACT NOW.



Chinese leaders know the devastating effect narcotics can have. The opium wars of the 1800s involved thousands of tons of opium pouring into China, which addicted millions of Chinese, devastated their economy, and contributed to their military loss against the British Empire.

In 1927, China erupted in a civil war between the Communist Party and the Nationalist Party. Communist leader Mao Zedong instructed his subordinates to grow poppies, create opium, and traffic

it into the non-Communist regions of China. As drugs became more readily available, more people readily used them. Opium weakened drug users, the people around them, their societies, their governments, and their militaries. The Communists then conquered the area—and took draconian measures to stamp out drug use, destroying poppy fields, imprisoning millions, and executing suspected traffickers.

After the Communist Party conquered mainland China in 1949, Mao actually nationalized opium production and started using narcotics as a chemical weapon to destabilize his rivals, primarily Japan and the United States.

During the 1950s and 1960s, Chinese Premier Zhou Enlai managed his nation's narcotics operations. In 1955, he allegedly told Egyptian President Gamal Abdel Nasser that the Communists would use drugs against the morale of U.S. forces in Asia (Edward R. Slack, Opium, State and Society). Soviet statesman Mikhail Suslov said in 1964 that Zhou's strategy was "to disarm the capitalists with the things they like to taste."

Recent Chinese doctrine articulates the use of a wide spectrum of warfare against its adversaries, including the United States, said a 2014 report from U.S. Army Special Operations Command. "The People's Liberation Army (PLA) colonels Liang and Xiangsui outline China's vision on how China will attack the United States through a combination of military and nonmilitary actions...These methods include trade warfare, financial warfare, ecological warfare, psychological warfare, smuggling warfare, media warfare, drug warfare, network warfare, technological warfare, fabrication warfare, resources warfare, economic aid warfare, cultural warfare, and international law warfare." (Sept. 26, 2014).

By turning a blind eye, at the very least, to Chinese fentanyl traffickers, the Chinese government enjoys the benefit of waging drug warfare against the Americans and weakening them. A Chinese military attack using actual chemical weapons would risk an overwhelming military response but using the chemical weapon of illicit drugs is a subtle siege that tears at the fragile fabric of American society by attacking not its strategic vulnerabilities but its moral ones.

America's self-inflicted and China-facilitated fentanyl epidemic is ripping apart families, multiplying crime, crippling the economy, and destroying the minds of the next generation of Americans.
